

Non-Member Supra Lockbox Access Quick Start Instructions

Quick Start Instructions for Non Member Access

Update 9/9/21

One-Time Only: Install eKEY App and Setup Account

The first time an ECBOR MLS Agent allows a NonMember access to an iBox, the NonMember will receive two text messages; an approval text with setup instructions and a text with a one-time authorization code. As long as the eKey app remains on the Smart Phone, additional authorization codes will not be needed.

Follow the 4 Steps:

- Select the link in the text message and download the eKEY app to your Smart Phone (Supra eKey).
- Accept the terms & conditions
- Set up the account information. The NonMember will be asked to create a 4-digit pin code. The code will be required to access the current iBox and on any future iBox accesses.
- Enter the authorization code from the text message into eKEY app. One authorization code is issued per Smart Phone setup. If the eKey app is deleted from the Smart Phone, a new authorization code will be required.

Open an iBox BT using your Smartphone

The keys to the property are in the iBox Key container located on the bottom of the box. To Open the iBox, please follow these steps:

- Confirm the Smart Phone's Bluetooth is turned on.
- Select the eKey application on Smart Phone.
- Select Obtain Key and enter the 4-digit Pin code. (Note most Smart Phones will automatically begin to connect while some users may need to select Begin or OK to activate the connection)
- 4. Turn on the iBox Bluetooth signal by pressing up on the bottom of the iBox. A red light will begin flashing on the front of the iBox. (For Smart Phones that requires an adapter, turn on the eKey adapter and point the infrared lens on the adapter to the infrared lens on the front of the iBox)
- 5. Upon success, press up on the bottom of the iBox to release the key container.
- 6. Remove the Keys.
- 7. At the conclusion of the showing, replace the keys in the key container and insert into the iBox.
