Housing Providers: Rental Assistance Could Be Yours to Help Keep Tenants in Homes

The Indiana Housing & Community Development Authority invite REALTORS® to a special presentation on the **Indiana Emergency Rental Assistance program**. Recent changes to the program allow property owners to start the application on their tenant's behalf and see a dashboard where they can view their tenant's application status in real time. The program can provide up to 15 months (up from 12) in assistance to help cover past due and ongoing monthly rent and utility payments (used to be only past due utility payments) for qualifying Indiana renters. **Mark your calendar for Monday, Oct. 25 at 2:00 p.m. ET/1:00 p.m. CT and plan to spend 30-60 minutes online with IHCDA.** Advance registration required; register below to receive the Microsoft Teams link.
