



Housing Providers: Rental Assistance Could Be Yours to Help Keep Tenants in Homes

The Indiana Housing & Community Development Authority invite REALTORS® to a special presentation on the Indiana Emergency Rental Assistance program. Recent changes to the program allow property owners to start the application on their tenant's behalf and see a dashboard where they can view their tenant's application status in real time. The program can provide up to 15 months (up from 12) in assistance to help cover past due and ongoing monthly rent and utility payments (used to be only past due utility payments) for qualifying Indiana renters. Mark your calendar for Monday, Oct. 25 at 2:00 p.m. ET/1:00 p.m. CT and plan to spend 30-60 minutes online with IHCDA. Advance registration required; register below to receive the Microsoft Teams link.



Special Note: Individuals living in Hamilton, Lake, Marion, and St. Joseph Counties, as well as in the City of Fort Wayne, are not eligible for the IERA program. Individuals living in these areas must apply for rental assistance locally. Get more information here.







Congress Needs to Focus on Affordable Housing

Did you know that the average American household can't afford to own a home today?

The reason: our country is experiencing a massive housing shortage of nearly **6 million units**. This gap also impacts rental markets across the country. We need Congress to address this problem now.

The Biden Administration has a plan to help build as many as 100,000 new homes over the next three years.

This is a good start, but this effort alone simply doesn't come close to addressing the need for more housing.

At the same time, the Administration is now supporting tax law changes before Congress that will limit private-sector investment in real estate construction - development projects that could help put a dent in our country's housing shortage and even create good-paying jobs for American families.

Tax changes currently being considered by Congress will affect the housing market and our economy.






Median Sales Price
